

INFORMATION ABOUT PRIVACY AND COOKIE POLICIES RELATIVE TO WEBSITE SISTEMIDITORNITURA.IT

This privacy policy describes the activities of data processing, also relative to personal data, implemented by SISTEMI DI TORNITURA DI PICCINI ALBERTO & C. SNC (hereafter referred to as the Data Controller/Company) through its website www.sistemiditornitura.it (hereafter referred to as the Website) and the commitments undertaken by the Company in this regard.

The Data Controller may process the user's personal data when they visit the Website and use the services and features available on the Website. Where contemplated by EU Regulation 2016/679, users' consent will be requested before processing their personal data. If users provide the personal data of third parties, they shall ensure that the data communicated to the Data Controller and the subsequent processing for the purposes specified in the applicable privacy policy are in accordance with EU Regulation 2016/679 and any other applicable legislation.

1 - DATA CONTROLLER

2 - PURPOSES FOR PROCESSING THE DATA COLLECTED

Users' data are collected to enable the Data Controller to provide its services, as well as for the following purposes:

3 – COOKIES

As is customary on all websites, this website also uses cookies, which are small text files that enable the company to store information about the visitors' preferences, improve the functionalities of the website, facilitate navigation by automating procedures (e.g., Login and website language), and for website usage analysis.

Session cookies are essential to distinguish between connected users and are useful to prevent a requested functionality from being provided to the wrong user, as well as for security purposes to prevent cyber-attacks on the site. Session cookies do not contain personal data and last only for the duration of the current session, i.e., until the browser is closed. Consent is not required for them.

The functionality cookies used by the website are strictly necessary for its use; they are connected, in particular, to an explicit request of functionality by the user (such as Login), for which no consent is required.

By using the website, the visitor expressly consents to the use of cookies.

4 – THIRD-PARTY COOKIES

This website also serves as an intermediary for third party cookies used to provide additional services and functionalities to visitors and improve the use of the website itself, such as the keys to access social media.

This privacy policy does not apply to services offered by third parties and does not have any control over their cookies, which are entirely managed by third parties. The data transfer agreement is stipulated directly between the user/visitor and the third parties, and the acquisition of consent for these cookies is, obviously, the responsibility of the third parties, while this website does not participate in any way in said transfer.

Consequently, information about the use of these cookies, their purpose, as well as how to disable them, if necessary, is provided directly by the third parties (see paragraph 5).

Display of content from external platforms

Statistics

The cookie used by Google Analytics (GA4) includes anonymization of the user's IP address. This is a web analytics service provided by Google Inc. that uses cookies stored on the user's computer to allow statistical analysis in aggregate form regarding the use of the visited website.

Data collected: Number of users. Session statistics. Approximate geographic location. Browser and device information.

5 – MANAGEMENT OF COOKIES

To facilitate the management of consent preferences, we provide herewith a cookie selection tool through which you can refuse the categories of purposes for which cookies are collected, in addition to being able to deny or give consent to all cookies managed with a single click.

Cookies are linked to the browser used and CAN BE DISABLED DIRECTLY FROM THE BROWSER, thus refusing/revoking consent to the use of cookies. It is important to bear in mind that disabling cookies may prevent the correct use of some functions on the website.

6 - DATA PROCESSING METHODS

Data are processed, for the purposes outlined in paragraph 2, with the aid of digital or telematic tools by the data controller and by persons specifically authorized by the data controller. Processing consists of data collection, registration, organization, storage, processing, amendment, use, and erasure.

7 – DATA DISCLOSURE

Your data is not subject to disclosure and will be processed exclusively by personnel appointed by the Data Controller, who are bound by confidentiality and have been given appropriate instructions for the proper processing of personal data. Your data may be transmitted to external parties who perform specific services or assignments on behalf of the company, serving for the performance of its business, in any case with a prohibition on disclosure.

8 – DATA TRANSFER

Your personal data will be processed in the EU and stored on servers located in the EU.

9 - DATA RETENTION PERIOD

The company will process your data for the entire duration of the working relationship and even afterwards, for periods consistent with the needs of business continuity, legal obligations, and for potential legal defense in judicial proceedings.

10 - OPTIONAL CHARACTER OF DATA COMMUNICATION

You are not required to communicate your data; however, failure to provide it may result in the inability to fulfill the activities outlined in paragraph 2 and therefore meet your requests.

11 - RIGHTS OF DATA SUBJECTS

Regarding the processing of your personal data, you have the right at any time to obtain confirmation of the existence or otherwise of data held by the company, to request their rectification, erasure, and restriction. You have the right to object to the processing of your personal data and the right to withdraw consent to the processing, without affecting the lawfulness of processing based on consent before its withdrawal.

You may exercise your rights by sending a registered letter with return receipt or by sending an email to the addresses indicated in paragraph 1 of this information notice.
